Module Learning Outcomes

1. Develop self in the diverse roles of the Operating Department Practitioner whilst delivering peri-operative care to differing patient groups across a wider range of clinical specialities, techniques and environments.

- 2. Assess, plan, implement and evaluate peri-operative care needs of patients within a variety of clinical disciplines. To include day case, in-patient and non-scheduled groups.
- 3. Analyse principles of pre-assessment which influence patient care planning and delivery of care.
- 4. Assess and prioritise patient care needs with supervision from a registered practitioner.
- 5. Distinguish between normal and altered physiology during a clinical emergency and demonstrate the management of specific clinical emergencies and trauma for differing patient groups.
- 6. Recognise the need for, initiate and participate in Basic Life Support & Intermediate Life Support procedures.
- 7. Select, prepare and check a range of emergency drugs (in accordance to local & national guidelines.
- 8. Demonstrate an awareness of, and practice within the framework of local and national Health and Safety policies.
- 9. Develop and practice within the framework of accepted Code of Professional Conduct and recognise own limitations in relation to professional practice.
- 10. Analyse using a wide variety of communication skills information on the care needs of the individual patient are met by taking into account the physical, emotional, psychological, and personal beliefs of the patient.
- 11. Communicate effectively with the healthcare team, patients, relatives and carers. Discuss the significance and support of communication required for patients, relatives and carers well-being during emergencies.
- 12. Recognise the value and contributions of self and the multi-professional team in the emergency situation.
- 13. Examine the causes, signs and symptoms and range of clinical emergencies and the methods used in identifying/monitoring them.
- 14. Demonstrate the ability to adapt to different clinical settings, urgency of care and patient groups.
- 15. Examine the protocols, techniques and equipment used in the management of an identified range of clinical emergency situations.
- 16. Demonstrate a working knowledge of all major national clinical emergency guidelines.
- 17. Discuss the principles and practice of defibrillation techniques.
- 18. Explain the mode of action, side effects and contraindications of a range of drugs used in emergency situations.
- 19. Identify how to access, retrieve and process information required for evidence based practice.
- 20. Evaluate the outcomes of clinical emergency situations, using self and peer reviews.
- 21. Manage the patient's airway in the immediate post-op period, to include both adults and children.
- 22. Prepare and administer prescribed drugs to a patient via different routes including IV (where possible) intra-muscular, subcutaneous, oral and topical.
- 23. Monitor and assess patients from all identified groups as they recover from general and regional anaesthesia. Recognise and take appropriate action to alterations in the patient's physiological parameters.
- 24. Check that all drains, dressings, wound supports and other support equipment is functioning correctly and take remedial action where required.

- 25. Assess, manage and implement pain relief strategies for improving patient comfort within all identified patient groups. Provide care in the immediate post-operative period to meet individual needs, concerns and beliefs.
- 26. Document care and treatment regarding the patient's condition during immediate post-operative period, and ensure this information is communicated to the receiving person when handing over the patient's care.
- 27. Develop an awareness of the complexity of individualized patient care in the immediate post-operative period.
- 28. Review how the type of procedure and the clinical speciality affect the requirements for post anaesthetic monitoring and care.
- 29. Explain the principles and demonstrate the techniques of using artificial airways and patient positions to maintain unobstructed respiration including how surgical and anaesthetic procedures may compromise the airway.
- 30. Collect and interpret physiological data used in the continuing care of individual patients in the immediate post-operative period.
- 31. Use a range of appropriate information systems and write clear, legible and coherent records.

Visits in Practice

A&E: Students learn about the clinical environment, protocols and triage procedures. Builds on the multi-disciplinary understand of clinical emergencies.

ITU: Demonstrating the interplay between theatres and ITU. Gives the students experience in advanced nursing techniques, as well as exposure to additional mechanical and pharmaceutical therapies. Reinforces the theory teaching of ABG's, ventilation, fluid balance and inotropic support. This placement builds on the multi-disciplinary team approach to patient care, whilst showing the students what happens to a critical patient once they have left theatre/recovery.

Pain team: Demonstrates the extended role of anaesthetic and nursing colleagues, whilst also demonstrating the need for good pain control whilst in PACU. This placement also gives the students an understanding of other pain control techniques and the challenges faced by both staff and patients.

X-ray: This should help contextualise and reinforce the theory sessions whilst help improve the student's diagnosis techniques, particularly in relation to emergencies and trauma. Again, this placement is designed to improve the students understanding the multi-disciplinary team and give them the skills necessary to work in this area safely and efficiently.

Patient Journey: The purpose of this short placement is to develop your understand of the process a patient undergoes when coming to the operating department. It is important that you recognises the patient journey as a whole and not in the isolation of an acute episode of care
